

We are pleased to inform you of the 2016 annual commission amount due to your county under Texas Tax Code Section 152.123, for your efforts in collecting motor vehicle sales tax on behalf of the state.

Your 2016 tax commission is **\$5,479.41**, which equals 5 percent of the tax and penalties collected for motor vehicle sales and use tax, motor vehicle seller-financed sales tax and Texas Emissions Reduction Plan (TERP) surcharge collections reported for your county during the calendar year 2015.

You will draw your commission from motor vehicle sales tax collections and TERP surcharge collections. Please retain **\$5,436.59** of the commission from 2016 motor vehicle sales tax collections and **\$42.82** from 2016 TERP surcharge collections.

You will enter the commission retained on the Comptroller's Texas Motor Vehicle Sales/Use Tax Surcharge Report (Form 14-115). The commission amount retained from motor vehicle sales and use tax collections, including seller-financed collections, must be entered in Item 8A. The commission retained from TERP surcharge collections must be entered in Item 8B.

You can retain the commission amounts for the year on one month's tax report if there are sufficient collections for that month. Otherwise, retain the commission over several months until the total commission has been retained.

FISHER COUNTY POLICY STATEMENT

Overview/Policy Statement

It is The Fisher County Commissioners Court policy to provide a safe and healthy work environment for all employees and visitors. In accordance with this, animals are prohibited from all Fisher County facilities and premises with the exception of authorized service animals and working animals as defined below.

"Facility" means any Fisher owned or leased facility, including the associated parking lots, grounds and common areas.

"Service Animals" refers to animals (primarily dogs) used to guide or provide assistance to persons with disabilities in the activities of independent living. The Americans with Disabilities Act (ADA) defines service animals as any animal individually trained to do work or perform tasks for the benefit of an individual with a disability. If an animal meets this broad definition, it is considered a service animal.

"Working Animals" refers to those animals engaged in authorized service to the corporation (e.g., guard dogs, pest control animals, police dogs).

Rationale

In addition to providing a professional and conducive work environment, this policy responds to concerns for the health and safety of employees and animals. Further, it limits potential distractions and disturbances in the workplace.

Scope

This Policy shall apply to all employees, contractors and visitors of The Fisher County Courthouse and facilities.


Applying The Policy

This policy provides for the health and safety of employees and County facilities by restricting animals in the workplace as follows:

- Unauthorized animals are not permitted in any area within the workplace, including the parking lots and grounds.
- Employees and visitors are reminded that bringing a pet to work and leaving them in a car is neither appropriate, nor safe and is prohibited in some jurisdictions. In order to accommodate individuals with disabilities, service animals are expressly permitted in all areas in the workplace.
- Employees who are in need of a service animal must obtain authorization prior to bringing the animal to the worksite.
- In all cases, only clean, trained, well-behaved, non-aggressive animals are allowed, and they are to be leashed and kept under control at all times.
- It is the animal owner's responsibility to ensure that animals relieve themselves outside and owners should not call upon co-workers or facilities staff.

- Individuals are reminded not to touch, feed or pet a service or working animal when the animal is working as it distracts the animal from the task at hand.







ORDINANCE NO. 2016-1

AN ORDINANCE PROHIBITING SMOKING IN FISHER COUNTY-OWNED FACILITIES

WHEREAS, numerous studies have found that tobacco smoke is a major contributor to indoor air pollution, and that breathing secondhand smoke is a cause of disease, including lung cancer, in nonsmokers. At special risk are children, elderly people, individuals with cardiovascular disease, and individuals with impaired respiratory function, including asthmatics and those with obstructive airway disease; and

WHEREAS, secondhand smoke has been classified as a Group A carcinogen like asbestos by the Environmental Protection Agency; and

WHEREAS, secondhand smoke contains more than 4,000 chemicals, including arsenic, formaldehyde, hydrogen cyanide and radioactive elements. More than 60 of these chemicals have been identified as carcinogens; and

WHEREAS, there is no safe level of exposure to secondhand smoke; and

WHEREAS, health hazards induced by breathing secondhand smoke include lung cancer, heart disease, respiratory infection, and decreased respiratory function, including bronchoconstriction and bronchospasm; and

NOW, THEREFORE, BE IT ORDAINED by the Commissioners Court of Fisher County:

That smoking is prohibited in all County-Owned Facilities: including but not limited to; common work areas, conference and meeting rooms, private offices, hallways, medical facilities, cafeterias, employee lounges, restrooms, and all other enclosed areas.




