

NOTICE OF SUBSTITUTE TRUSTEE'S SALE



EXHIBIT A

All of that certain 2.284 acre tract, lot, or parcel of land being out of Block F of the Campbell's Addition of the City of Goldthwaite, Mills County, Texas, said addition being of record in Volume 93, Page 482, of the Deed Records of Mills County, Texas, and being the same land as conveyed as a 2.276 acre tract in a Warranty Deed from Douglas Glenn Storey et ux., to Tommy M. Adams, dated April 9, 1998, being of record in Volume 229, Page 530, of the Deed Records of Mills County, Texas, and is further described as occupied as follows;

BEGINNING at a 1/2" iron rod set by a chain link fence corner post in the intersection of the Westerly line of Barrow Street and the southerly recognized line of Eight Street, being the NEC of Block F, for the North East Corner of this;

THENCE South 20 degrees 39 minutes 26 seconds East, with the westerly line of said Barrow Street, 338.89 feet to a 1/2" iron rod set for the South East Corner of this;

THENCE South 64 degrees 29 minutes 32 seconds West, with the southerly line of said 2.276 acre tract, 231.23 feet to a 3/8" iron rod found by rail road tie, being the southerly Corner of said 2.276 acre tract, for the Southerly Corner of this;

THENCE with the occupied fence line along the westerly and interior corners of said 2.276 acre tract, North 20 degrees 40 minutes 47 seconds West, 81.82 feet to a found 3/8" iron rod by fence corner post, South 75 degrees 41 minutes 20 seconds West, 52.23 feet to a found 3/8" iron rod by fence corner post, and North 20 degrees 17 minutes 42 seconds West, 307.93 feet to a 3/8" iron rod found by fence corner post, being the NWC of said 2.276 acre tract, in the southerly line of said Eight Street (Not occupied), for the North West Corner of this;

THENCE North 76 degrees 52 minutes 31 seconds East, with the occupied fence line along the southerly line of said Eight Street, 282.83 feet to the place of beginning and calculated to contain 2.284 acre of land in area.
