Beginning at a $\frac{1}{2}$ " rod set for the north corner of this tract and in the east corner of a 0.115 acres tract surveyed out of the called 8.17 acres tract on this day, and in the southwest line of a tract conveyed in Volume 1272 Page 867, and brs. south 10 degrees 51 minutes 41 seconds west a distance of 496.77 feet from the north corner of the called 8.17 acres tract, and said rod is in the east corner of a 0.115 acre tract surveyed out of the called 8.17 acres tract on this day;
