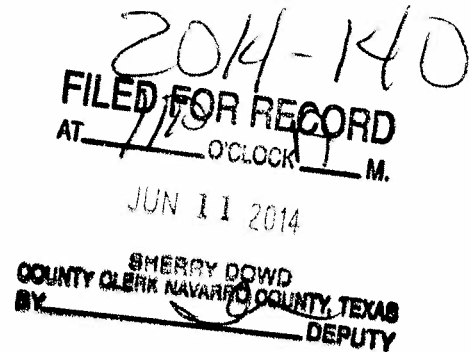
Notice of Public Meeting of the Appraisal Review Board:
